Greetings! You have been provisionally selected for admission in M.Ed. *programme* Session 2019-21 under Department of Education, Magadh University, Bodhgaya. You are directed to appear for Counselling with Original Certificate & One set of Xerox copy on **24.04.2019** during **10:30 A.M. to 03:30 P.M.** at Department of Education, Magadh University Campus, Bodhgaya, with the following documents:

1. Candidates are required to deposit a Bank Draft/Challan in favour of **Director, Department of Education, M.U.** payable at **BodhGaya** for **Rs. 10000/- on the day of counselling & Rs. 44000/- at the time of admission. Total Fee of 1st Semester Rs. 54000/-** (*Challan copy may be obtained from Department of Education, M.U. after verification of the documents*).
2. All Original documents Marks/Certificate from Matriculation onwards.
3. College Leaving/University Leaving Certificate in Original (It is mandatory)
4. Certificate of Physical Handicappness in Original (*where applicable*) issued from Civil Surgeon/ C.M.O.
5. M.U. M.Ed. Entrance Test-2019 Admit Card (Original Copy).
6. Caste Certificate (for reserved category) issued from S.D.O./D.M. only.
7. 4 (Four) recent passport size coloured photographs.
8. Xerox copy of Aadhaar Card.
9. One set self attested xerox copy of all documents.
10. Those who are working with Govt. school in the capacity of school teacher have to submit NOC from their employer.
11. No original document would be procured by the department, it is for the purpose of verification only.
12. Affidavit by the **Notary** (*Content of Affidavit is mentioned below*)

Provisional selection is not the guarantee of admission. Appearing candidate of merit list must come with their result/marks sheet. If any thing found incorrect/misinformed/without substantive proof/human error, the claim for admission will not be entertained. If the candidate fails to appear on stipulated date & time as mentioned in the letter what ever may be the cause, his/her claim for admission will be ceased. It is mandatory to submit an **Affidavit** by the **NOTARY** that the certificates, marks sheets and other papers submitted by the candidate is correct and genuine.


